

COSHOCTON COUNTY FAIR

ROYAL COURT COMPETITION

A royal court consisting of a king, a queen and attendants will represent the 2022 Coshocton County Fair. The King and Queen will receive a sash to be worn during the Fair and while visiting other Ohio events, Fairs, or parades. Attendants will also receive a sash. Queen will receive a tiara.

Sponsors/supporters of this event include. Linnets Flowers on the Square, House of GA Fisher Jewelers, Senior Fairboard, WTNS Radio, Garden Patch Greenhouse, and The Warehouse Restaurant.

RULES AND REGULATIONS: Must be:

1. Resident of Coshocton County or Coshocton County School District
2. A High School senior in which the Fair occurs
3. Exemplify good behavior/character
4. The Queen or runner-up must be able to compete in the Ohio Fairs Queen Contest held in Columbus at the OFMA convention, in January.
5. If the Queen is unable to fulfill her obligation to compete in the State Queen competition, she must relinquish her title and tiara to the first runner-up. The runner-up will be crowned queen and will represent Coshocton County at the State Queen Competition.
6. Must NOT be committed of a misdemeanor or felony
7. Must attach a head/shoulder picture with application
8. The Royal Court MUST be available to reign over the Fair at various times throughout the week as directed by the contest committee. Failure to comply will result in relinquishing your title and awards.

JUDGING CRITERIA:

1. Applicants who apply will be judged on two separate occasions. First interview is a casual dress interview and will be held on Sunday, September 11, 2022, starting at 1:00pm in the Fairboard Office. The Royal Court committee will call applicants with an interview time. The second interview will be a formal dress held in Hunter Arena on Friday, September 30, 2022, starting at 5:00 p. m. A panel of three judges will interview on both occasions.
2. Application MUST be received by September 2, 2022, at 5:00pm in the Fairboard Office
3. Late entries will NOT be accepted
4. Specific Judging Criteria are:

Poise

Personality

Communication Skills

Responses to Questions

Appearance and Presentation

Activities, Leadership, Participation, Initiative, and Achievements

5. It is understood and agreed that the Coshocton County Fair Royal Court Committees method of conducting the competition is at its sole discretion. It is further understood and agreed that the Royal Court committee shall determine times, method and manner of judging of the competition and giving of the awards is at its sole discretion. The judge's decision will be final.
6. The Coshocton County Fair Royal court committee will be following the guidelines in the Ohio Fairs Queen Contestant contract.
